Message from the UEZ Director

Since our last publication the State of New Jersey has undergone many changes. First we elected a new Governor as CEO of the State of New Jersey and with the new administration many budgetary cuts and political changes have adversely affected the **Urban Enterprise Zones** throughout the state and here in Paterson. Secondly, newly elected Governor Chris Christie is considering the termination of the **Urban Enterprise Zone** Program, which would have a tremendous negative impact on the economic vitality of this city and its local businesses.

The Paterson **Urban Enterprise Zone** has served as a catalyst for key investments in Paterson and as a result, millions of dollars have been leveraged from both the private and public sector. The **UEZ** continues to be a vital element in the success of creating a more business-friendly environment in Paterson through incentive programs to help local businesses grow and thrive. Increasing commerce by increasing shopper traffic is one of the main goals of the **UEZ**. Now these programs are under the scrutiny of being eliminated by the new "state administration."

Despite the threat against the existence of the **UEZ**, many of us have launched our own attempts to thwart Governor Christie's action against the **Urban Enterprise Zone** Program. Because of the efforts of our local **UEZ** member businesses, the administrative offices of Trenton and the State Legislators have been inundated with letters and phone calls that champion with us to save the **UEZ** Program. We are so very grateful to each and every one of you who wrote letters, made phone calls and even took time out to attend special hearings in Trenton on behalf of the **UEZ**. Ultimately it will be your response to the "call for action" opposing the elimination of the **UEZ** that will make an impact on our legislators and the governor's office in deciding the fate of the **UEZ** Program as they vote on the budget July 1st. Together we will continue to work diligently on behalf of the City of Paterson and the **UEZ** business community to safeguard the programs of the Paterson **UEZ**. If we don't work together, your business could also be negatively impacted with the loss of the 3 ½ % reduced sales tax, sidewalk and façade improvements, as well as the

low interest loan program. One of our membership businesses is taking this very seriously and has hired a lobbyist to help us in our efforts to "save the UEZ program." We will keep you updated on the various hearings so we can act expeditiously and effectively to address the mandates of the Governor's office.

If your e-mail address has changed, please call the UEZ office at 973-321-1212 x 2263 so we can update your files. We expect to be sending out a lot of emails between now and July 1st as developments unfold.

On a more positive note, changes have been made to the recertification process. The applications that used to be done yearly to recertify your business in the program, will now be processed every three (3) years. However, businesses still have to submit an Annual Reporting Form (top sheet) and UZ-5-SB-A form every year. Trenton has been sending out letters, but please do not be confused...you must fill out these two forms yearly to comply with the 3 year recertification process. Please call us if you have any questions. Our staff will be happy to assist you.

As we approach a new fiscal year in July, we understand that the State of New Jersey is going to face difficult choices when deciding which programs make the cut and which programs do not. We know the UEZ program has been very successful and we have proven that to the state of New Jersey time and time again. Every zone must balance their budget and we must present project proposals to the Authority meetings in Trenton for approval. Each and every UEZ zone which presents projects is grilled on the scope of work and budget prior to

approval. The Governor also has 10 days to veto any project that was presented and approved by Authority. After the project begins, we must then report the status of the progress and the financial status each quarter to the Department of Community Affairs (DCA) and the Economic Development Authority (EDA). This program works and without it, the city will have little funding for economic development projects. We have been told by the State of New Jersey that the sales tax revenue beginning in July will not be given to the various zones, but instead will be used to balance the state budget. With that being said, there isn't any money to run the UEZ offices administratively and there will not be any additional money for economic development projects should this program be salvaged.



I want to again take the time to thank each of you for your letters, phone calls and e-mails of support for the UEZ. Please make sure you reach out to your State Legislators and ask them for their support on July 1st not to eliminate the UEZ Program. In addition, without the sales tax revenue that is collected through our retail business members, we will not be able to administratively run the UEZ offices and we will not be able to further the economic development of our city. Let's all continue to "save the UEZ program" and hope for the best as we move forward.

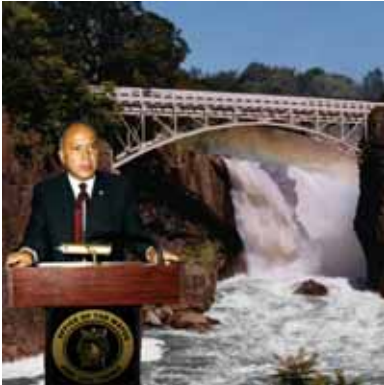
A Message from Mayor José “joey” Torres

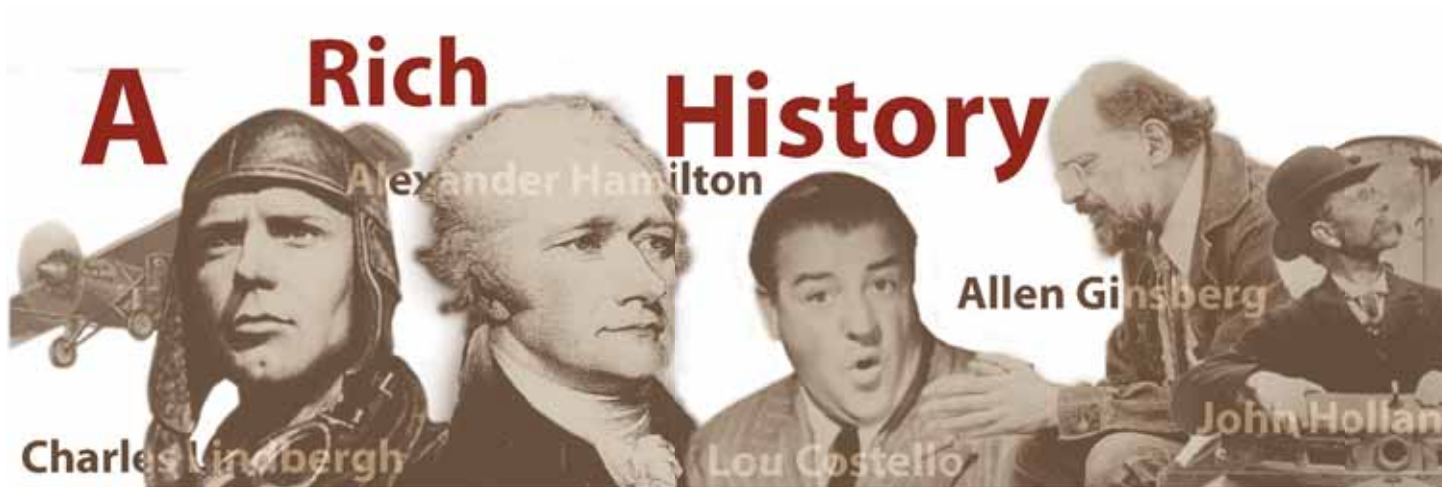

About the UEZ Program

The **Urban Enterprise Zone (UEZ)** is a state-designated program to alleviate unemployment in approximately 37 municipalities throughout the state of New Jersey. The City of Paterson was designated as an **Urban Enterprise Zone** in 1994 and plays a vital role in the restoration of Paterson. The sales tax collected in Paterson has provided the **UEZ** with the funds to administer 71 economic development projects. The following list is just an example of the programs and projects which offer a great number of advantages to **UEZ** members:

- *Business Improvement Grants*
- *Sidewalk Matching Grants*
- *Revolving Loan Program*
- *Video Surveillance Cameras*
- *Main Street Streetscape*
- *Small Business Development Center*

Today, Paterson retains its proud history, and with the recently designated Great Falls National Park, Paterson is making a true transformation to the economic engine that will generate hundreds of jobs and millions of dollars for the city. Central to this revitalization is the **UEZ** Program, enabling **UEZ** retail members to charge 3½ % sales tax giving them a competitive edge over other businesses. **All UEZ business members however, benefit from the tax exemption allowed for operating supplies.** 100% exemption from the NJ State Sales and Use Tax for the purchase of all tangible property (excluding motor vehicles) includes the following:

- *Office Supplies*
- *Office Equipment*
- *Services, including installation*
- *Building Materials*
- *Repairs and improvements to existing properties*

Business Improvement Grants

Jacksonville Catering, located at 36 Marshall Street, has been a member of the **UEZ** since August, 2008. The beautiful facility has undergone major renovations, repairs and upgrades with funds from the Business Improvement Grant, which includes new brick façade, windows, doors, fencing, soft & hard landscaping, lighting and sidewalk.

UEZ Business Spotlight

Accurate Box Company

Governor Chris Christie recently visited a successful small business in Paterson as part of his effort to spotlight New Jersey's urban areas to help draw new businesses to New Jersey.

Accurate Box Company is one of the largest independent box manufacturers of litho laminated packaging in the United States. The family-owned firm, which moved here from Newark in 1983, has been a landmark in the Paterson community for more than 28 years.

Founded in 1944 by Henry E. Hirsh, the grandfather of the current president and chief executive officer, Lisa Hirsh, Accurate box operates out of a 285,000 square foot facility located at 86 Fifth Avenue in Paterson. The company is a certified woman-owned business and has been a certified member of the Paterson Urban Enterprise Zone since 1995.



Accurate Box Company employs approximately 185 employees, of which about 72% live in Paterson or other **UEZ** communities. Paterson is the company's only location to date.



Elevator Doors, Elevator Entrances, Elevator Cabs

Elevator Doors, Inc. located at 15 Jane Street, has been a thriving business in Paterson for 60 years. Elevator Doors, as well as Elevator Cabs and Elevator Entrances has been a member of the **UEZ** since its inception in 1994, and attributes viable sales and services to the use of the 3 ½ % reduced sales tax benefit that the **UEZ** offers. The companies have been able to thrive and grow in the City of Paterson because of a growing and diverse market, skilled labor force and prime location. With the three businesses at this location, about 83% of their employees are Paterson residents, with some having been with the company for 25 years.

They have a staff of expertly trained engineers, production and erection specialists, highly trained in their crafts, thus guaranteeing ease of installation and the finest results. Among the company's most significant accomplishments is the engineering and designing of the elevator cabs and entrances for the world famous Statue of Liberty at Ellis Island.

Feldman Brothers Electric Supply Co., Inc.

Feldman Brothers Electric Supply Company has been a landmark business in Paterson since 1922, and became a member of the **UEZ** in 1994 and moved to its new location in 2002. The company is a wholesale distributor of electrical supplies, selling to electrical contractors, home owners, commercial and industrial contractors. The company currently employs 108 full-time professional lighting consultants and specialty project developers.

Feldman Brothers outgrew their former location because of the higher traffic volume, due largely to the **UEZ** reduced sales tax incentive to their customers. The company is now housed in a larger facility within the **UEZ** at 26 Maryland Avenue. Feldman Brothers recently began an export division of their company, and they also expanded their product line to include commercial fire alarm equipment, security cameras, and DVR systems. Come by and see the spacious new design center and show room display of thousands of electrical fixtures and specialty items.



Excel Hobby Blades Corp.

This company became a member of the **UEZ** in 1996, five years after relocating the business at 481 Getty Avenue. Since joining the program, the company has experienced a growth in their employee base by approximately 60%, of which nearly 95% of the employees reside in Paterson and other **UEZ** communities. Excel Hobby Blades began as a manufacturer of hobby, arts and craft supplies..

It has since been able to expand and grow their business by purchasing new Thermal Forming equipment used to introduce another line of manufacturing products.



Sidewalk Matching Grants

Sachs & Zitcer is a wholesale plumbing and heating supply company which has been a member of the Paterson **UEZ** since its inception in 1994. This company, located at 389 Tenth Avenue, has been a recent benefactor of the **UEZ** Sidewalk Matching Grant program. Sachs & Zitcer is the first **UEZ** business to integrate this latest snow removal procedure using the built-in Hydronic system directly into the sidewalk applications. "Being a heating supply company, this snow melt system served two purposes. First, the sidewalks will never have to be shoveled or salted again; therefore, greatly increasing the life of the concrete. Secondly, it demonstrates this new concept to other businesses and customers who are inquisitive as to what type of snow melt we use on our sidewalks. The neighboring businesses were burdened with the task of shoveling their sidewalks numerous times this past winter, and we never once lifted a shovel to rid the sidewalk of dangerous snow and ice," stated owner Robert Adamo.

Revolving Loans

The Revolving Loan Program was created for qualified **Urban Enterprise Zone** businesses to provide the financing necessary to promote economic growth within the City of Paterson. The loans are available to qualified **UEZ** certified businesses that are located within the **Urban Enterprise Zone**. The **UEZ** Loan program makes additional financing available for projects that might not otherwise be financed through a private bank. The Revolving Loan Program also allows resident businesses to save money on the cost of their debt, thereby allowing more money to be reinvested in the business' expansion and creation of additional jobs. Our current rate is one percent under Prime for 10 years.

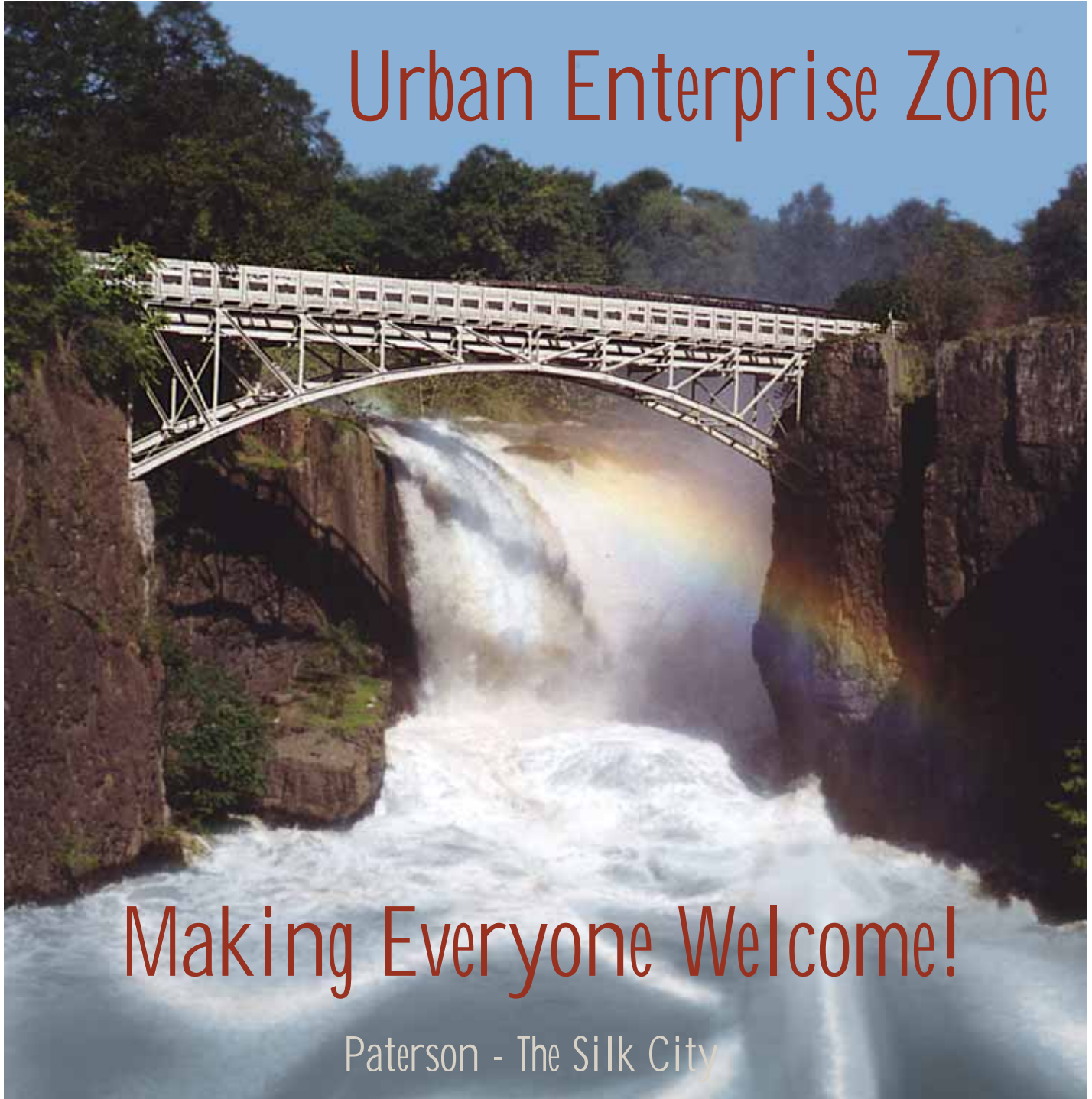
